Terms and conditions \$10 Voucher – 13cabs & DFO Black Friday Giveaway

The following terms and conditions (Terms and Conditions) apply to the \$10 Voucher – 13cabs & DFO Black Friday Giveaway (Melbourne and Brisbane) (the **Giveaway**). By entering into the Giveaway, a person acknowledges and warrants that they have read, understood and accepted these Terms and Conditions.

Promoter

Giveaway Period
